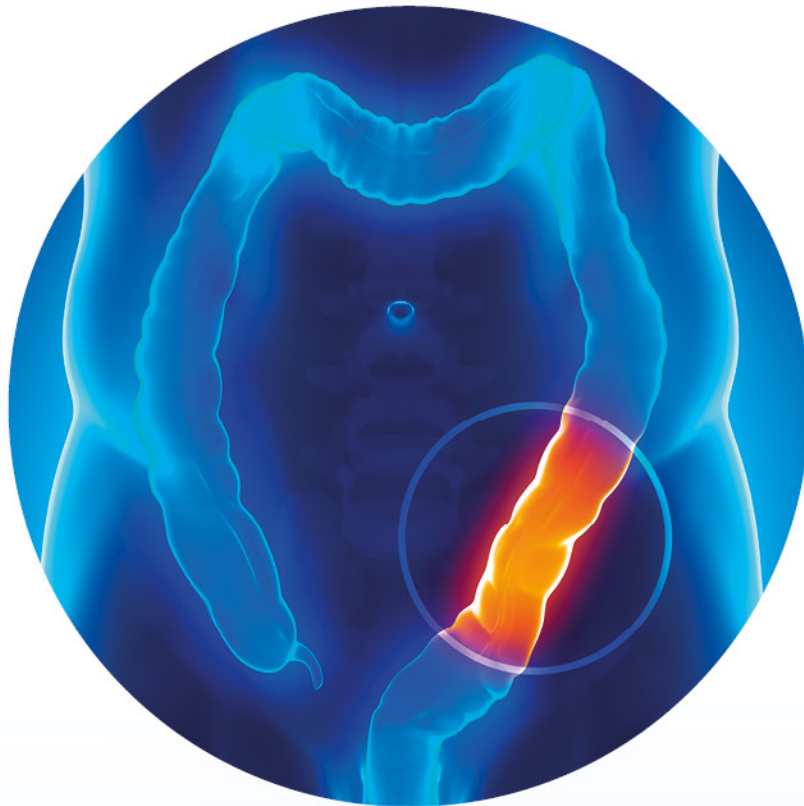

ACTION & INGREDIENTS

- **Senna:** ▪ Increases intestinal peristalsis.
- **Aloe Vera:** ▪ Provides prebiotic fibers (polysaccharides, glucomannan etc.).
- **Fennel:** ▪ Provides fenitholi that counteracts bloating.
- **Psyllium:** ▪ Provides fibers and stimulates the muscle wall of the intestine.
- **Rhubarb:** ▪ Contains anthraquinones that promote intestinal peristalsis.
- **Cascara:** ▪ Invigorates lose muscles of the digestive tract and enhances intestinal peristalsis.
- **Boldo:** ▪ Contains boldine that protects liver and counteracts indigestion.
- **Mallow:** ▪ Has soothing properties. Protects intestinal mucosa and has anti-inflammatory action.

Not to be consumed in cases of pathology of the digestive system, if you are pregnant or breastfeeding or by people with intolerance to one of its components. Keep it away from children (under 3 years old).

RECOMMENDED IN CASES OF constipation.

Note: In cases of chronic constipation it is recommended to follow a diet rich in fruits and fibers. You must also drink at least 2 liters of water on a daily basis or as much water as your doctor allows you to drink.

DOSAGE

- Take 2 tablets every night before sleep.

Casia angus dry extract 6-8% to sennosides	160 mg
Aloe vera d. e. 19-22% to hydroxy anthraquinone derivatives	160 mg
Foeniculum vulgare pm	120 mg
Ispaghul	200 mg
Rheum palmatum dry extract 5% to hydroxy anthraquinone derivatives	60 mg
Ramnus purshiana dry extract 10-12% kaskarosides	160 mg
Peumus boldus dry extract 0.05% to boldina	40 mg
Malva sylvestris leaves pm	120 mg
Casia angus leaves pm	90 mg
